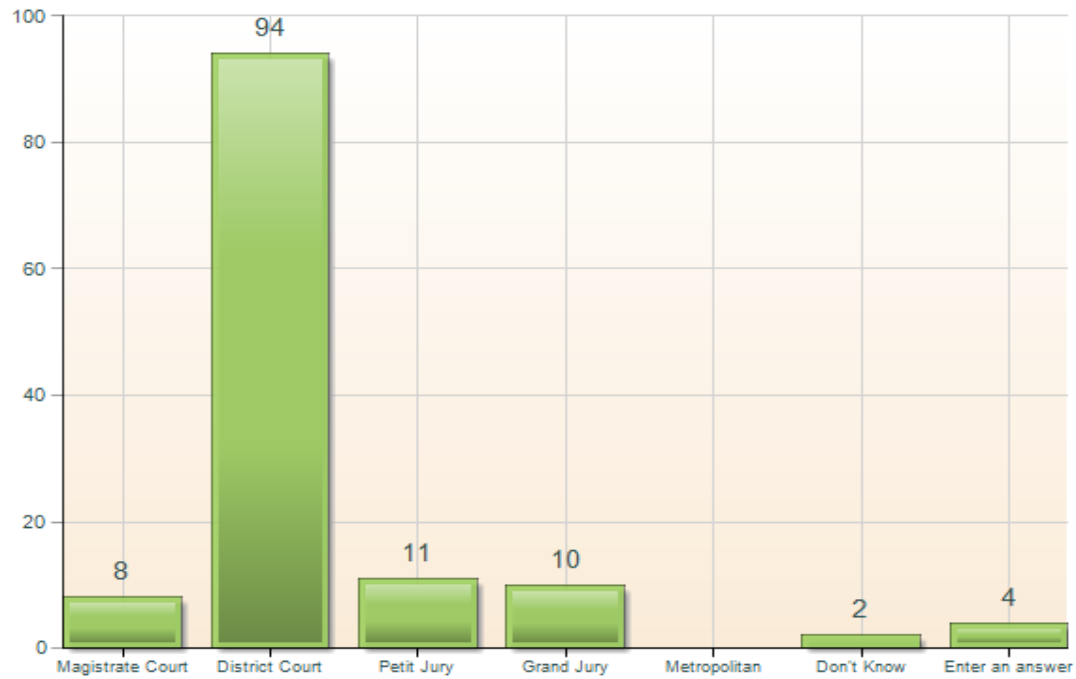

Please indicate at which court you recently completed jury service. .

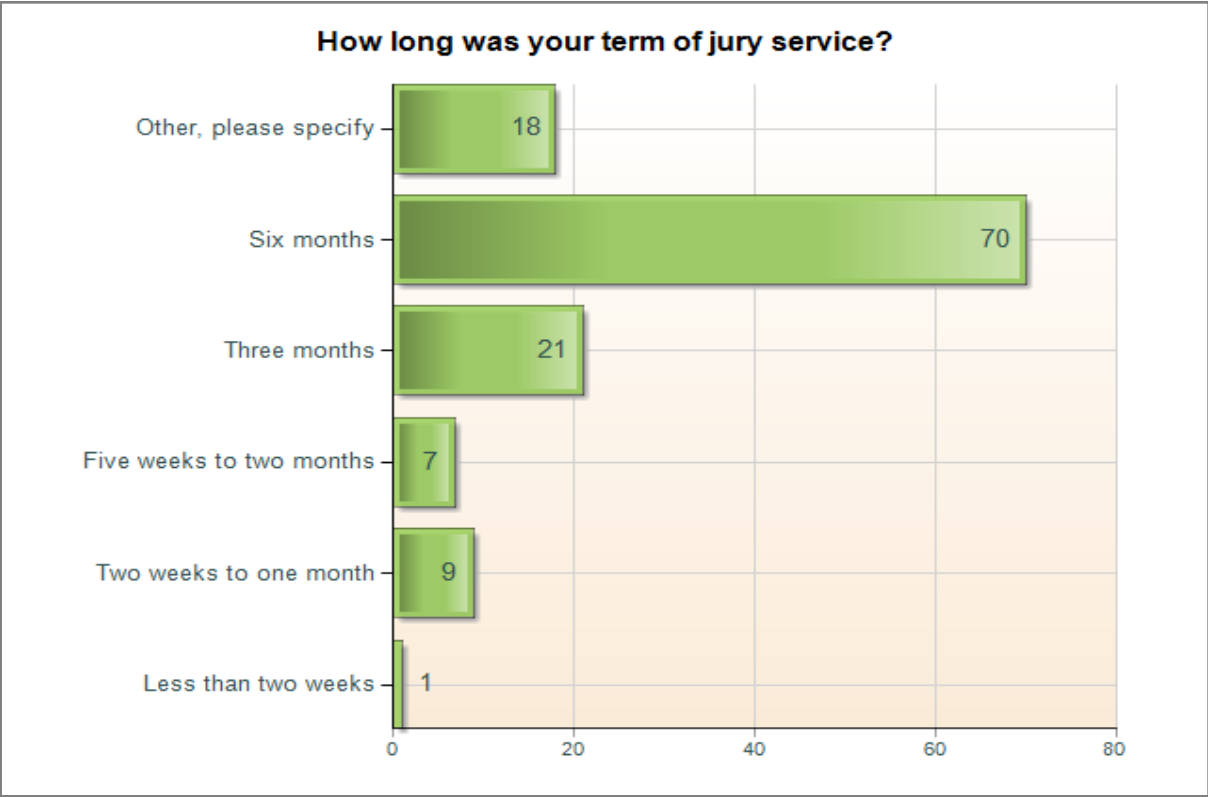

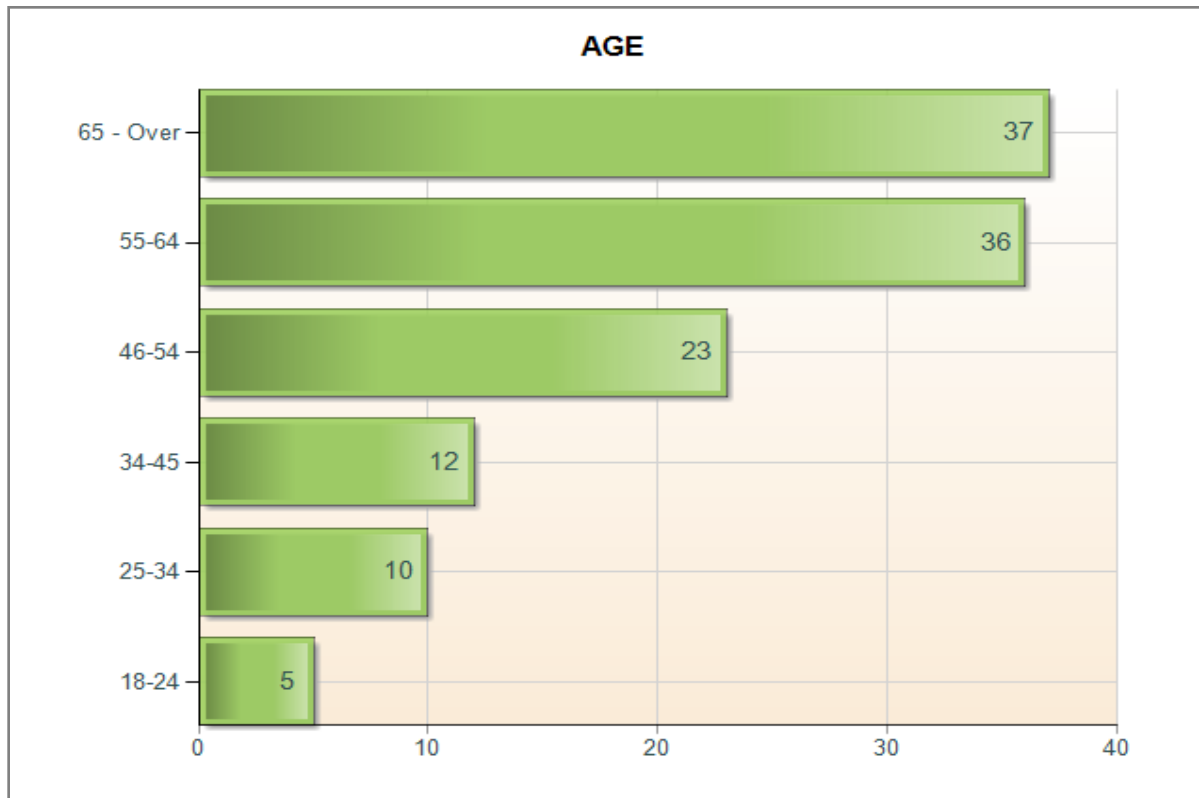
When you were first called to be a juror what was your reaction?

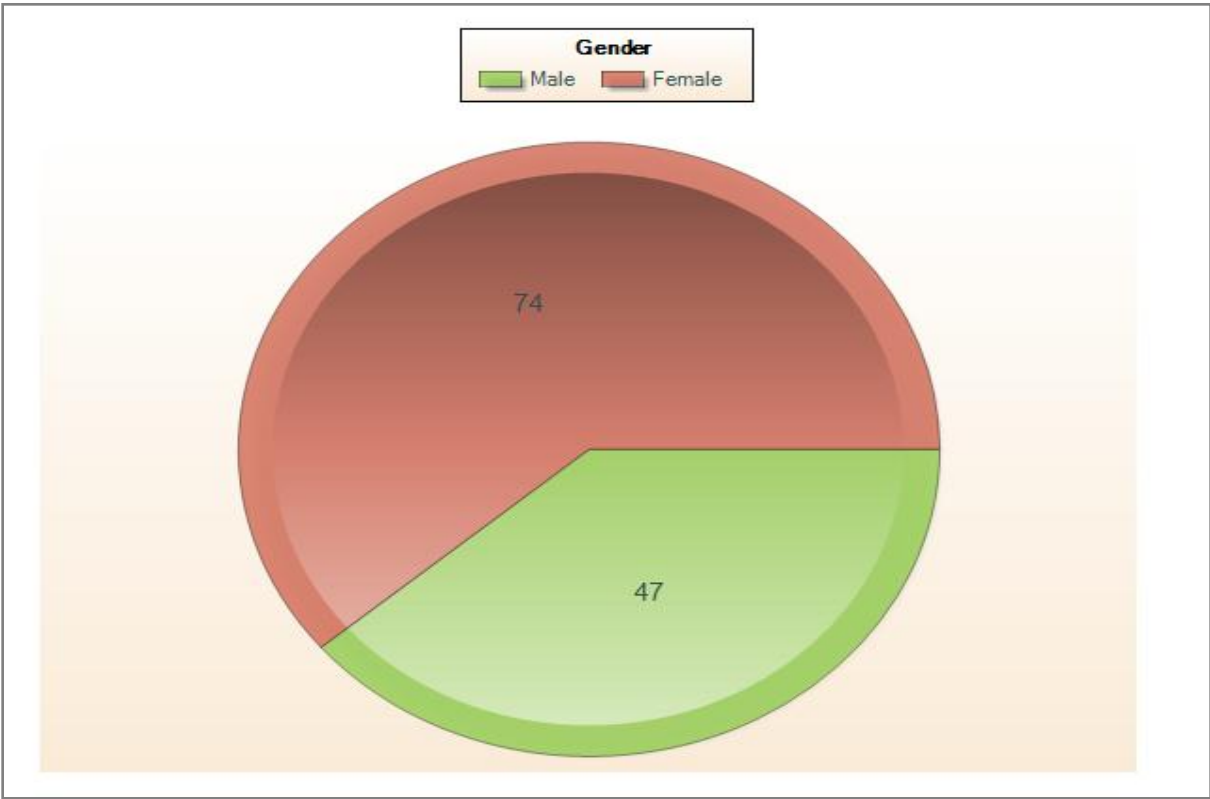


After having served, what is your impression of jury service?

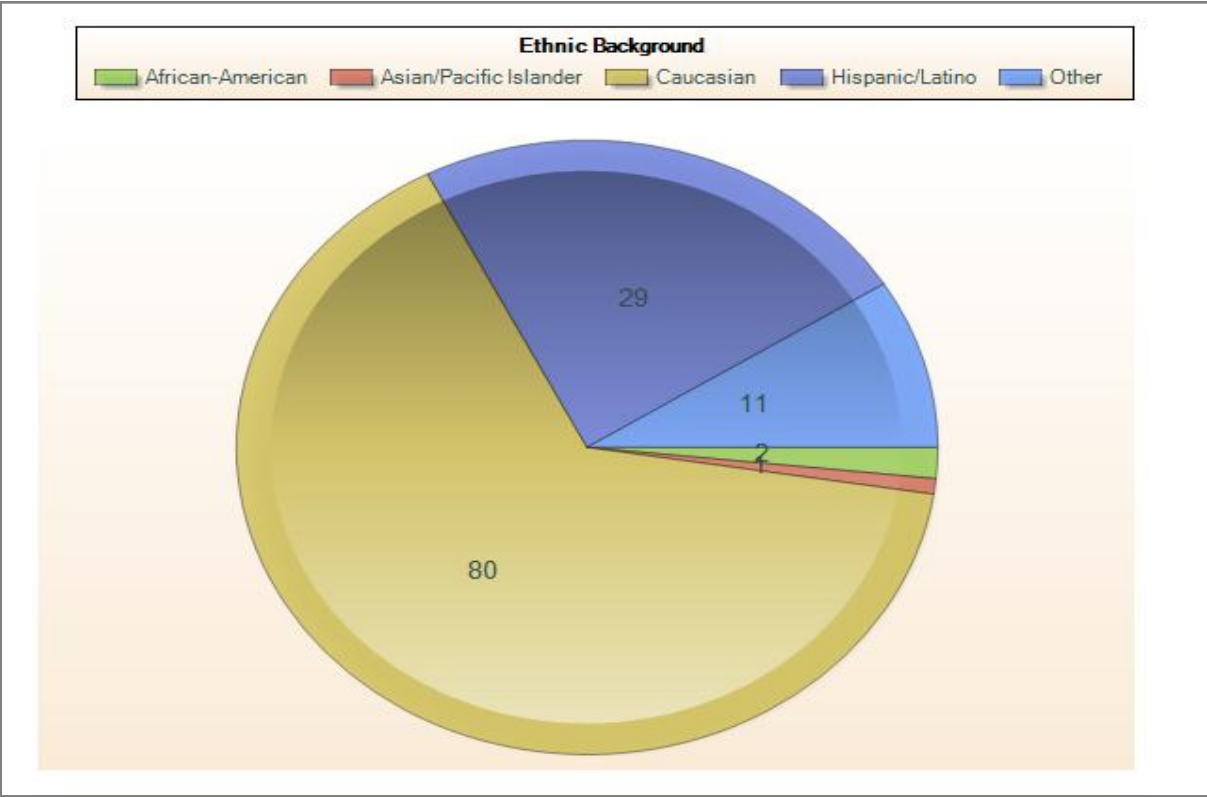
